UNIVERSITY REJECTS FAT STUDENTS

Dr. Carl Hamilton, Academic Dean of Oral Roberts University in Tulsa, Oklahoma, has announced a program of compulsory diet-

HILDA

For the second year in a row, the Board has voted not to offer Hilda calendars to NAAFA members for sale. As reported by Bill Fabrey in his President's message in the May-June 1976 Newsletter, when it was decided not to sell Hilda calendars for the first time in five years, sales had dropped too much to justify our purchasing a quantity to sell to those interested NAAFA members.

Furthermore, there had been some criticism of Hilda—she was not fat enough; she is a "sexist and exploitative treatment of the female body, as are all nude or semi-nude female" calendars; many of the verses accompanying the pictures were considered derogatory. However, we still have copies of the 1972, 1974, 1975 and 1976 Hilda calendars available for new members and Hilda "buffs" at \$1.50 each. We hope you'll let us have your feelings on this subject to guide us in future years.

We do have a pleasant surprise for those of you who are interested in Hilda.

ing that has led to the expulsion of students who didn't agree to or succeed at this program. He said that the policy affected the "individual who is voluntarily overweight simply from eating too much too often." Each student is tested. If fat comes to more than 35 percent body weight for a woman or 25 percent for a man, the student is placed on a weight-loss program and must submit an approved diet menu once a week.

The American Civil Liberties Union in Oklahoma City has filed a 75-page complaint with the Federal government, asking for a review of the university's discriminatory policies.

To NAAFA's knowlege, this is the first time the ACLU has taken on the cause of fat rights, and it is hoped that this will be the beginning of a deluge of lawsuits on behalf of fat people. NAAFA is cooperating fully with the ACLU, and has offered whatever assistance it can give to the affected students. A press release has also been issued in this matter.

More than 100 people attended the October 22 NAAFA-Dance that was held at the Dancing Oasis in New York City, breaking previous records for a NAAFA social function.

Many of the non-members seen at the dance were attracted by several ads placed in local newspapers and mailings to exmembers. Lisbeth Fisher, Chairperson of the NAAFA-Dance Committee, observed that an unusual variety of people, including fat and thin, young and old, and from distances as far away as Washington, D. C., Maryland, Pennsylvania and even California, all helped to make the evening a success.

Veterans of previous NAAFA functions could not recall seeing so many couples dancing and conversing, many of whom remained at the fund raiser until well after 2 a.m.

As one observer noted, "If you measure the success of a dance by the number of people who arrived as singles and departed as couples, then surely this evening was a success. When's the next one?" (Not to mention the hard-pressec NAAFA treasury, which also benefited by the event.)

FIRST NATIONAL FAT FASHION EXHIBIT

On October 17, manufacturers of largesize clothing made fashion history in Los Angeles, according to several newspaper articles received from NAAFA members.

The first major national exhibit of fashions for fat women featured outfits worn by big, beautiful models, and drew shouts, applause and wolf whistles. The trade show included 62 manufacturers specializing in the large and half-size markets—sizes 18 to 52.

NAAFA member Nancy Austin, comedienneturned-designer, was the hit of the show in such outfits as a sequined evening gown and a lacy, ultra-feminine wedding gown.

The theme of the show was "Big is Beautiful." Nancy, who weighs about 270 pounds, says that over 30 percent of the women in this country need large sizes, which means that the approximately 22 million previously-overlooked female customers are finally receiving the fashion attention they deserve!

MEMBERSHIP REPORT

Lisbeth Fisher, Chairperson of the Membership Committee, has reported that, since NAAFA opened its formal office in Ossining in February of this year, the NAAFA membership has grown by approximately 40 percent. BOARD VACANCIES FILLED

At its meeting on September 16, the Board of Directors confirmed the appointments by President Fabrey to three vacant positions on the Board, previously reported in this Newsletter. Howard Clist and Ernest Harff, active on the Board in previous years, were asked to fill seats vacated by Joyce Fabrey and the late Naomi Shadowitz. Dianne Rubinstein, a newcomer on the Board, was appointed to fill the seat vacated by Karen Scott-Jones.

NAAFA's Constitution provides that "in the event of the resignation, removal, or death of any Board member before the normal expiration of his [or her] term, a new Board member shall be appointed by the President, subject to the approval of the Board, to fill out the term of the 'vacant seat." (Bylaws, Art. II, Sec. 7)

According to President Fabrey, "Making such appointments is not an easy task, because I must satisfy my own conscience and the existing Board at the same time. Anyone I appoint should usually have a proven track record with this organization, and there are always a limited number of good candidates from which to choose. I do make an attempt, wherever possible, to appoint those who bring a new or different outlook to the organization, who can help keep the Board a balanced group of people representing a wide variety of NAAFA members.

"The Board, most of which is made up of individuals who are elected by the NAAFA membership in June of each year, has always supported my efforts to provide a diversity of Board members."

FAT CHANCE

The long-awaited and promised first issue of FAT CHANCE was submitted to the Publications Committee a few weeks ago. However, some problems arose over the intended content of the publication, so a committee was formed at the October 14 Board meeting to set guidelines.

BOARD ELECTS NEW RECORDING SECRETARY

At its meeting on September 16, the Board elected Gail Gold as Recording Secretary, to fill the vacancy created by the June resignation of Joyce Maloney, who had served as Recording Secretary since December, 1975.

A competent steno-typist, Gail is studying to become a court reporter. She is acting Chairperson of the Greater New York Chapter.

FUND RAISING MADE EASY

Our new Fund Raising Chairperson, Dianne Rubinstein, is full of ideas to help NAAFA raise money. Since NAAFA exists solely on membership fees, donations, and fund raising, this committee is a very important part of NAAFA.

One way in which you can help, without having to spend any money other than that which you would spend on groceries, is to send to the NAAFA office all purchase confirmation seals clipped from the packages containing Goodman food products.

Goodman will pay NAAFA 5 to 10 cents per seal, depending on how many we collect. Some of the many Goodman's products include egg noodles, boxes of soup, many egg noodle products, various types of matzo, and Chinese noodles.

The empiration date on the offer from Goodman's is Nay 31, 1978, so this will give us plenty of time to collect lots of seals and make extra money for NAAFA. Please send your Goodman's purchase confirmation seals to the NAAFA office as often as you wish.

FAT FEATURED FAVORABLY IN MEDIA

Notice has been made of signs of growing acceptance by the media of fat people. Several clothing manufacturers have actually used heavier-than-average models in advertisements for their lines of largesize fashions. The October COSMOPOLITAN and November GLAMOUR and LADY'S CIRCLE actually contained articles (listed on their front covers:) supporting the premise that plump can be pretty (although they've got a long way to go before their "plump" models are truly fattened up): The September issue of MS. magazine had some interesting articles on being fat. The November GOOD HOUSEKEEPING has an expose on the Atkins', Fredericks', and Linn diets, and Charlotte Montgomery lists seven companies that manufacture panty hose for the large woman.

Finally, world-famous beauty Elizabeth Taylor is listed on the front cover of the November ESQUIRE as "fat, fortyish and still fabulous." The article itself states, "She claims to get a sexual pleasure from eating (and refers to herself as a 'lump'). It is a tribute to her beauty that she remains striking in spite of the padding."

[Ed. note: The padding referred to above and the soft, rounded figure that is characteristic of Elizabeth Taylor may well have helped to give her a universal sex appeal throughout the many years of her stardom. We do not find it difficult to understand why she is still considered appealing to many, including the article's author, who seems to be surprised at his own feelings about her.]

REPORT ON SUBMARINE AFFAIR

The NAAFA office is still in correspondence about the Naval discrimination aboard the USS Los Angeles during President Carter's visit last June, which was the beginning of a NAAFA letter-writing campaign.

The latest correspondence received was a letter from the Assistant Secretary of the Navy on behalf of President Carter. However, NAAFA officials are still dissatisfied and intend to pursue the matter further. We shall report any further details in the next issue of the Newsletter.

HISTORY MADE AT TEACHERS' CONVENTION

A civil rights proposal that included wording favorable to fat people was passed recently in Baltimore at the 110th Annual Convention of the Maryland State Teachers Association, marking the first time such wording has ever been used in such a resolution.

Due to the determined efforts of NAAFA member Russell Williams, a delegate from Hagerstown, Maryland, the word "size" was successfully inserted in the resolution that finally passed on October 15, after two days of debate, with 90 percent of the delegates voting in favor of the final wording:

"The Maryland State Teachers Association publicly objects to all forms of discrimination based on factors of competence.

The forms to which we object shall include, but are not limited to, race, size, religion, age, handicaps, sex, and sexual preference." [Emphasis ours.]

In his speech to the MSTA, Mr. Williams mentioned NAAFA and said in part:

"Size discrimination is a form of discrimination often unmentioned and overlooked by 'normal' sized persons... As educators, we should take the lead in being aware of and objecting to more than the current headline discriminations. The question in hiring non-standard-sized people should be, 'Are you the most competent person available for this job?' Other criteria should not be allowed to enter the hiring or firing process."

The significance of the final resolution is that any of the 15,000 teachers in Maryland who are members of the association and feel that their human rights have been violated for any of the above reasons, including <u>size</u>, now have access to the association's extensive legal resources.

[We applaud Mr. Williams and his courageous stand at the Convention that resulted in this victory for fat teachers (or those of any "unpopular" size) in Maryland.--Ed.]

FILM RIDICULED WOMAN, SHE ALLEGES IN MD. SUIT

[The following article was submitted by Nick Tolliver of Takoma Park, Maryland. It is reprinted from THE WASHINGTON POST, 4/13/77.]

"The film 'Mission Nutrition' had been running for several minutes when some members of the audience—a seventh grade class at Montgomery County's Parkland Jr. High School—began laughing and taunting one of their classmates, according to a suit filed in the County Circuit Court.

"What prompted the outburst last December, according to the suit, was the appearance in the film of the student's mother shopping at the local Giant Food Store as the narrator intoned, 'Some of our chubby friends seem to take in more than they burn up,' or, the suit maintains, 'words of a similar disparaging nature.'

"The movie has now been withdrawn from showing by the school system, and the details of the film--including what the narrator said--are in dispute.

"The suit, filed by Beverly Kouzel of 14200 Chadwick Lane, Rockville, contends that she was filmed without her knowledge and that the showing of the film caused her to 'become an object of ridicule and to suffer emotional distress, humiliation and embarrassment...'

"Arguing that the film invaded her privacy, Mrs. Kouzel is seeking \$700,000 in damages from Astra Films of Washington, which produced the film; Paul L. Brand and Son, Inc., of Falls Church, which distributed it; the County School System; and Giant Food.

"Leonard Grossman, owner of Astra Films, disputed the contentions made in the suit, saying that everyone who appeared in the film-made seven years ago-had been made aware that they had been filmed. He said the cameramen were instructed to have everyone who appeared in the film sign a statement acknowledging they knew they had been filmed.

"Brand said that as distributor he was not responsible for content. The school system's attorney said he has not yet drafted an answer to the suit. But a school spokesman characterized its position as being that of 'an innocent by-

stander' and said that school officials, who buy 1,500 films a year, said they had not seen the film in question. A reporter's effort to reach an attorney for Giant Food was unsuccessful.

"According to the school spokesman, two prints of the film were purchased from the Brand Co. for \$300 in February, 1973. After Mrs. Kouzel called school officials December 13, both prints were withdrawn from circulation, the spokesman said.

"Mrs. Kouzel declined to comment when called by a reporter. According to court documents, the 7-year-old film shows her weighing about 100 pounds more than she actually weighed last December. Her attorney, William F. Abell, disputed the assertions of school officials. He said the officials were 'well aware' that the film was made at the Aspen Hill Giant Food Store. 'Our contention is they've got to get permission for this sort of thing,' Abell said. 'It's not like she was just there in a general crowd of people. She's fully recognizable by anyone who knows her. None of the others in the film are used that way. She's singled out.'

"Grossman of Astra Films said his company primarily makes films for candidates for political office and that the nutrition film was a speculative venture. It was not selling, and Astra stopped trying to market it several years ago, he said. As far as he can remember, the film contains no disparaging statements about overweight people. 'Our intention was to do a film on nutrition, ' he said. 'There was no intention to hurt anybody.' He said the suit 'will effectively put us out of business whether we win or not. We've been found guilty just by the accusation. No political candidate will touch us now. '"
